Overview of the LTSS Reform Initiative

Why Reform Indiana's LTSS System?

From 2010 to 2030 the proportion of Hoosiers over 65 will grow from 13% to 20%. Indiana's disjointed system must be reformed to meet growing demand and to ensure Choice, drive Quality and manage Cost.



Choice: Hoosiers want to age at home



- 75% of people over 50 prefer to age in their own home – but only 45% of Hoosiers who qualify for Medicaid are aging at home*
- The risk of contracting COVID and impact of potential isolation drives an even increased desire to avoid institutional settings

Cost: Developing long-term sustainability



- Indiana has about 2% of the U.S. population, but over 3% of nursing facilities
- LTSS members are 4% of Medicaid enrollment, yet 28% of spend - only ~ 19% of LTSS spend goes to home and community-based services (HCBS)
- For next ten years, population projections show 28% increase in Hoosiers age 65+ and 45% increase in Hoosiers age 75+

Quality: Hoosiers deserve the best care



- AARP's LTSS Scorecard ranked Indiana 44th in the nation
- LTSS is uncoordinated and lacks cultural competency
- Payment for LTSS services is poorly linked to quality measures and not linked to outcomes

Indiana's Path to Long-term Services and Supports Reform



Our Objective

- 1) 75% of new LTSS members will live and receive services in a home and community-based setting
- 2) 50% of LTSS spend will be on home- and community-based services

Key Results (KR*) to Reform LTSS

- 1 Ensure Hoosiers have access to home- and community-based services within 72 hours
- 2 Move LTSS into a managed model
- 3 Link provider payments to member outcomes (value-based purchasing)
- 4 Create an integrated LTSS data system linking individuals, providers, facilities, and the state
- 5 NEW: Recruitment, retention, and training of workforce objective (in development - updates to come)



Role of the Advisory Group

Role of the Older Hoosier & Caregivers Advisory Group



The Advisory Group will provide valuable feedback and recommendations on how to effectively engage older Hoosiers and caregivers and to ensure that voices of aging Hoosiers and their caregivers are heard by:

1. Guiding us as we seek to appropriately engage with under-represented populations to promote equity in the LTSS reform process.
2. Providing feedback on ways to ensure quality services for older Hoosiers through LTSS reform.
3. Sharing suggestions on who and where we should engage with older Hoosiers and caregivers across the state;
4. Exercising leadership in organizing forums and inviting older Hoosiers and caregivers to events;
5. Helping with dissemination of information and materials;
6. Supporting FSSA's LTSS reform efforts over the next 3 years; and
7. Facilitating grassroots community relationship building among local organizations that intersect with older Hoosiers.

Scope of Work with FSSA

ADvancing States has a three-pronged integrated set of activities to support LTSS Reform over three years (2021 – 2023):

1. Multiple Rounds of Stakeholder Engagement
 - Older Hoosiers & Caregivers
 - Direct Service Workers
2. Business Acumen Development for CBOs
3. LTSS Provider Education

We will also provide limited MLTSS program design support as needed



Stakeholder Engagement: Purpose and Approach

Stakeholder Engagement Purpose

Talk to older Hoosiers, families, caregivers, providers, and direct care workers so that they can:

1. Give feedback on what is working and what is not in the current LTSS system.
2. Identify the elements that constitute a quality LTSS system.
3. Share their experiences and needs so they can be incorporated into the State's LTSS program design.



Stakeholder Engagement Approach



1. Multiple rounds of engagement between fall 2021 and November 2023
2. Obtain feedback on specific stages of reform effort
3. Focus on LTSS participants and caregivers as well as providers
4. In person and virtual sessions



Stakeholder Engagement Approach



Convene listening sessions where consumers are, during the day/evening/weekends



Partner with IMHC to ensure diverse representation in listening sessions



Willing to meet with provider organizations, community groups and other interested parties



Provide feedback to stakeholders after each round
