Organizational Structure


The director is appointed by the Governor and oversees a staff of 280 FTE.



Key State Initiative

In 2020, in partnership with the Vermont Legislature and Governor Phil Scott, Vermont was able to pass Act 156, an Older Vermonters Act. This act lays out key principles of services, supports and protections for older Vermonters, identifies the Department of Disabilities, Aging, and Independent Living (DAIL) as the subject matter expert across state government to guide decision making in state government for programs, services funding and initiatives related to older Vermonters, addresses coordination of strategies with those key principles, names the DAIL Departmental Advisory Board in a monitoring role and articulates the connections between the Older Americans Act and the state HCBS system.

The Act also enhances Vermont's State Plan on Aging requirements and requires DAIL to work in concert with the Governor's Agency of Administration to develop a **Vermont Action Plan for Aging Well** to be implemented across state and local governments, the private sector and philanthropies. That plan is intended to promote aging with "health, choice and dignity in order to establish and maintain an age-friendly State for all Vermonters". A link to Act 156 is below:
