A family caregiver is a person who assists a relative with short- or long-term limitations. It can be through either formal (paid) or informal (unpaid) supports.








# One in Five

- Nearly 20% of Americans were providing unpaid care to an adult with needs in 2020.
- It is estimated that 45% of those unpaid caregivers have experienced at least one negative financial impact due to caregiving.
- Difficulties faced by this population continue to trend upwards as we move forward in the national caregiver shortage


Administration for Community Living "The shortage of direct care workers has become a **national crisis** and a serious civil rights issue. Increasing numbers of people with disabilities and older adults who want to live in the community – a right protected by the Americans with Disabilities Act and other civil rights laws – are unable to get the services they need to do so."

We need **1.3 million** direct care workers just to keep up with demand.




### **Limited Provisions**

While most programs allow some family members to provide care, in self-directed programs, immediate or close family members such as spouses, parents, or children are often restricted.

CMS policy highlights their main concern with family caregivers:

"[Ensuring that] participant choice and control be preserved when legally responsible relatives are paid for providing care."






### Appendix K

During the Public Health Emergency, several states implemented changes to their self-direction programs using Appendix K of the 1915(c) waiver.

Around 39 states created temporary policy changes related to provider qualifications that allow family and legally responsible individuals to provide care.







Utilization of Paid Parent of Minor Child Option in North Carolina's Community Alternatives Program (CAP/C)

31% of children served by GT Independence in North Carolina utilized the Appendix K flexibilities to utilize a parent as a paid caregiver.


### After the PHE Ends

Despite continued challenges faced as a result of the direct care workforce shortage, only half of the states with Appendix K provisions intend to implement policy at the conclusion of the PHE to continue to allow family caregivers to provide formal care.



### The Stigma

In many programs, certain family caregivers are not permitted as eligible providers of formal (paid) supports.

There is a belief that they're more likely to commit fraudulent activity despite real evidence. Some people also believe that family members shouldn't be paid for work they are already responsible for doing.







### Families worry over the future of Medicaid caregiver payments that were expanded during the pandemic

"States found that being flexible with caregiver payments helped keep residents served during the pandemic, said Kate McEvoy, executive director of the National Association of Medicaid Directors. She said surveys have shown, too, that people generally like receiving care from family members.

But she also noted that there are concerns both nationally and at a state level about the potential for fraud when paying family members as opposed to an agency that may be subject to more oversight. States also want to make sure that any family caregivers are trained properly and provide quality care."



### The Reality

Family caregivers work hard every day to provide for the needs of their family. In many situations, they are the best option to provide care, because they know their relative the best.

They have the potential to provide crucial support to resolving the current caregiver shortage. Data shows that instances of fraud are **not** increased in these arrangements.


# Does allowing family members to be paid caregivers work?



### **Unpaid Caregivers**

AARP Public Policy Institute reported that family caregivers provided **over \$600 Billion worth of unpaid work** in 2021. That adds up to over 36 Billion hours of unpaid care during the year.

*It was a 28% increase from 2017.* 








### **GT Community** Sherri and Her Mother, Lois

"I just felt kind of helpless...we started pretty much spending my dad's savings on help at night. Of course, [we] went through dad's funds and then I got a reverse mortgage on the house, and I was just watching funds constantly. ...I wanted her to have the best life ever, but it takes funding to do that and keep her in the house."





*"People who self-direct show a strong sense of responsibility in regard to the services they use and the funds expended." - NASUA* 

This is no different for participants who rely on family caregivers to provide necessary services.

Many of these family caregivers are providing services well beyond what they expect to be compensated for.
